## **Decaf 40 cups**

1 package coffee (Gold foil bag – “*Decaf*”)

## **Regular 80 cups**

2 packages coffee (Silver foil bag – “*Regular*”)

- ❖ Coffee, sugar, napkins, tea, etc. can be found in the kitchen cabinet.
- ❖ Volunteers purchase 1/2 gallon of regular milk and treats for approximately 80 people. *\*Revised Amounts\**
- ❖ Please put sugar, milk pitchers, stirrers and napkins on the table away from the counter.
- ❖ Please put one carafe of decaffeinated coffee and 8 – 10 hot cups on the Seniors’ table.
